

NJ SCHOOLS PTA/PTO REVENUE SHARING PROGRAM

Astral Energy welcomes your participation in our unique revenue sharing program. You can make a difference by using Astral Energy as your supplier of natural gas. A portion of every dollar spent will be reinvested back into the community. This is our way of saying thank you for your support.

- Astral is a direct supplier of natural gas. We buy gas wholesale directly from the producer and deliver that discounted gas to New Jersey customers.
- PSE&G, your current local utility, will remain so, Astral delivers the gas to PSE&G who distributes that gas to your home. PSE&G currently bills you a standard distribution charge.
- When you elect to use Astral Energy as your supplier of natural gas, nothing changes except the opportunity to realize a 4% to 7% projected annual savings.
- PSE&G continues to bill your account as usual on a monthly basis, and you will not receive a bill from Astral Energy. The utility pays Astral.
- If you experience any problems with your service or smell gas, PSE&G still services your account. You are currently being billed by PSE&G on a monthly basis as a service charge.
- Astral does not commit any household to a long term contract; customers can elect to go month to month, and can switch suppliers at any time.
- There is no penalty or charge from PSE&G to switch to Astral, and likewise if you elect not to continue with Astral, there is no penalty or charge to go back to PSE&G.
- **Simply provide the School Office with one complete PSEG bill, and then we will handle the rest. It will take a month to process the transaction.**

- ❖ 轉換至 Astral Energy 後，您的天然氣費用預計在一年內將可節省大約 4% 至 7%。
- ❖ 每個月您仍持續從 PSE&G 收到帳單並支付款項，PSE&G 仍向您收取手續費，您所加入 PSE&G 的電路及天然氣設備維修費、以及其他各種電器維修項目及費用依然不變。
- ❖ 如果您的天然氣管線及設備出現問題，PSE&G 仍會為您的作維修服務。
- ❖ 您不必與 Astral 簽約，加入時無需手續費，隨時可更換其他公司，更換時也絕無罰款。
- ❖ 如果 Astral 的天然氣供應出現問題，PSE&G 將會馬上接手，絕無斷層問題。
- ❖ 只要您持續使用 Astral 提供的天然氣，Astral 將從您所消費的金額中撥出部分利潤，長期贊助中文學校，愈多家庭參加金額就愈多，如果有 100 個家庭參加，Astral 預計每年大約可贊助中文學校 \$1,000.00。
- ❖ 如果您同意轉換，請將任何一份完整的 PSEG 的帳單交給「博根辦公室」即可，我們需要大約一個月的時間來完成轉換手續。

Astral Energy – Fund Raising Program Q&A:

Q1: Astral Energy is offering an unique Revenue Sharing Program to help raising funds for non-profit organization. How do the families of BCS and Bohua sign up for that?

A: CSC doesn't have a physical location with its own PSEG bill, but CSC members can still sign up to raising funds for CSC or BCS or BoHua.

Q2: The rate for Astral Energy fluctuates each month, so if the family decided to switch over, they might not have a fix rate on the monthly basis?

A: Not only Astral's rate fluctuates, all the commodity rates fluctuate based on the NYMEX (The New York Mercantile Exchange) rates. FYI, Astral does offer three difference rate options for their customers, please see this page, you may select fixed rate or variable rate: <http://www.astralenergyllc.com/pricing-plans>. When enrolling if non of the rate plans is selected, then “Plan A: The Economy Plan (Variable Plan)” will be applied.

Q3: When will the donation send to my school?

A: the donation check will be written once a year. In the computer we will have different set up for each entity to separate the donation. To know which family is under CSC or BCS or BH, is not a problem.

Q4: If I have any problem with my service, who should I contact?

A: If you experience any problems with your service or smell gas, your current utility company (For example: PSE&G) still services you.

Q5: How do I sign up to support my Chinese school?

A: If any family agrees to switch their natural gas supplier to Astral Energy, all you need to do is to bring in a copy of your PSE&G bill To Ms. Shi-Ru Lin at the BCS office desk, or email to her at pikachulin@yahoo.com, and then you will receive letter to confirm that you switched. It will take at least 1 month to actually get the gas supply.
